

Air Emissions

Web EHSdesk™ provides a fully integrated suite of web-based software applications designed to support administrative, operational, and business process information management associated with Environment, Health, and Safety (EHS).

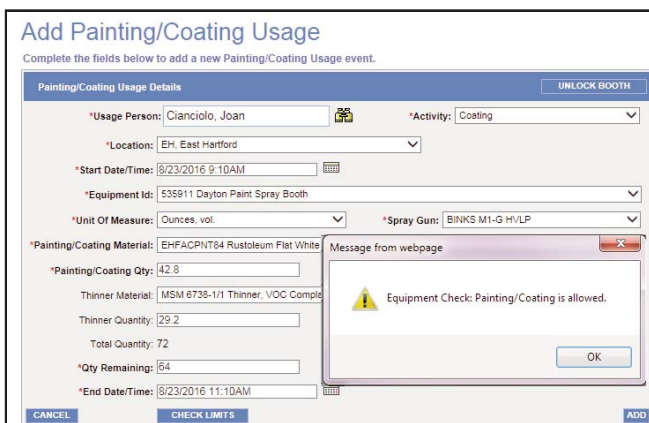
The **Air Emissions (AIR)** application is the overall umbrella for applications related to air emissions to help drive regulatory/permit compliance. The **Painting/Coating** application provides an emissions collection and reporting system for paint/coating/thinner usage at booths or other processes. The **Fuel Burning** application (coming soon) provides an emissions collection and reporting system for natural gas, diesel, and other fuels used at boilers or other fuel burning equipment. The **Stacks** application maintains an inventory of air emissions sources (stacks, vents, fugitive, etc.).

Features and Functionality

- Contains all necessary data for real time compliance across a multi-permitted facility
- Inventories available with allowable paint/thinner properties and allowable fuels
- Permit limits are factored in with exceedance notifications/rules
- Configurable emissions factors are assigned per paint per paint booth and by allowable fuels

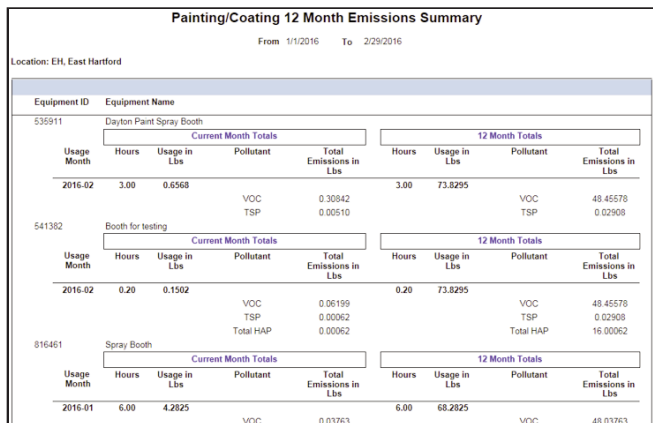
Benefits

- Enables real time visibility into emissions limits to ensure permit compliance on a daily basis
- Provides the ability to prevent or minimize exceeded permits directly at the operator level
- Provides instant notification via e-mail when limits have been exceeded
- Automates complex manual calculations to derive emissions
- Simplifies compliance reporting with predefined reports



Add Painting/Coating Usage Page

- Easy-to-use daily logs with optional paint thinner usage
- Automatic calculation of emissions by pollutant is saved for each painting/coating or fuel burning entry; administrators retain the ability to override entries
- Exceeded permit limits for the equipment or facility are tracked with e-mail notification to a configurable distribution list
- Paint booths and fuel burning equipment can be grouped together for limit purposes or assigned to a site limit
- Stacks can be related to equipment and control systems

Painting/Coating 12-Month Emissions Summary Report

E-mail/Reports

- Ad hoc reporting is available using a flexible search window with multiple filters and sorts; query results can be printed or saved to an Excel™ or Acrobat™ format
- Painting/Coating and Fuel Burning 12-Month Emissions Summary
- Painting/Coating Usage and Fuel Burning Usage with Emissions reports which can be e-mailed to supervisors weekly
- Notification e-mail sent to painting/coating and fuel burning equipment distribution lists if a limit is exceeded
- Inventory reports for stack/equipment/control systems data

Integration Points

- **EHSdesk Admin:** select paint booths and fuel burning equipment from a distinct master list of company-wide equipment
- **EHSdesk Material Tracker (MAT):** designate materials as Painting/Coating or Fuel Burning
- **EHSdesk Equipment Characterization (EC):** assign paint and fuels used at the equipment and assign related stacks/control systems to equipment

Compliance

- Facilitates compliance to local Air permits and ISO 14001
- Facilitates compliance with 40 CFR 50 through 85 and 40 CFR 87 through 97
