




Powered Industrial Vehicle

Web EHSdesk™ provides a fully integrated suite of web-based software applications designed to support administrative, operational, and business process information management associated with Environment, Health, and Safety (EHS).

The **Powered Industrial Vehicle (PIV)** module provides a mechanism to document PIV Registrations and PIV Permits. PIV Registration utilizes a checklist that helps document inspection results and determine if the vehicle is authorized for use. PIV Permit tracks important information (e.g., issue/expire dates, medical clearance information, authorized vehicle types), which is printed in the form of a PIV Permit. PIV can be used as a standalone module or as part of the Safety suite.

Features and Functionality

- PIV data managed via a user-friendly, step-by-step interface
- Two distinct processes for PIV registration and PIV permit
- Links to centralized equipment inventory
- Checklist to determine/document vehicle inspection results


